
About Us

Mission and Vision










126 men, women, and children in FY 2020-2021. With those clients, we had 689 interactions by providing advocacy, information, and referrals.

Number of Clients by Month




Gender of New Clients










Location of Examination








Expense Per Visit

UW Milwaukee: 'Tracking Our Truth'

St. Croix Valley SART has partnered with University of Milwaukee-College of Nursing, for project 'Tracking Our Truth'. We recognize that interpersonal violence against women is higher among American Indian Women than any other racially defined group. New services in Northern Wisconsin that Tracking Our Truth will offer will allow for more options provided to survivors of sexual assault, through culturally-supportive advocacy focused medical care at non-system based locations with advocacy provided through partnerships from Oakwood Haven, St. Croix Tribal Health & Human Services and Embrace. 'Tracking Our Truth' is an amazing benefit and opportunity to support and empower survivors in their healing journey allowing them to make the best choice for them in each moment. Education




St. Croix Valley Sexual Assault Response Team is invited to present at multiple schools in Pierce and St. Croix counties teaching to middle and high school students on the importance of healthy relationships, consent, and forms of abuse.

We are also asked to speak with Law Enforcement, Community Organizations, and other community events and organizations as needed/invited.


This year, because of the COVID-19 pandemic, our presentation numbers were significantly reduced for safety reasons. However, with 19 presentations consisting of 419 participants, we were able to reach a significant audience to teach about consent, healthy relationships, and abuse.

Number of Participants




Nursing



All survivors receiving forensic medical exams are educated by our nurses on HIV prophylactic medications and complete a risk assessment. This education and risk assessment allows the patient to make an informed decision about their medical needs.

> Fiscal Year 2020-2021 Numbers of patients educated: 67

Advocacy




Advocacy does not start or stop with an exam. Many advocacy interactions occur without an exam or after the exam is completed. For the FY 2020-2021, there were a total of 630 advocacy only interactions (no nurse exam completed) for 52 clients. This averages to 12 interactions per client. Interactions include: text check-ins, phone conversations, in-person meetings, etc. Depending on the type of case, the average number of interactions is significantly greater based upon the needs of that population.




